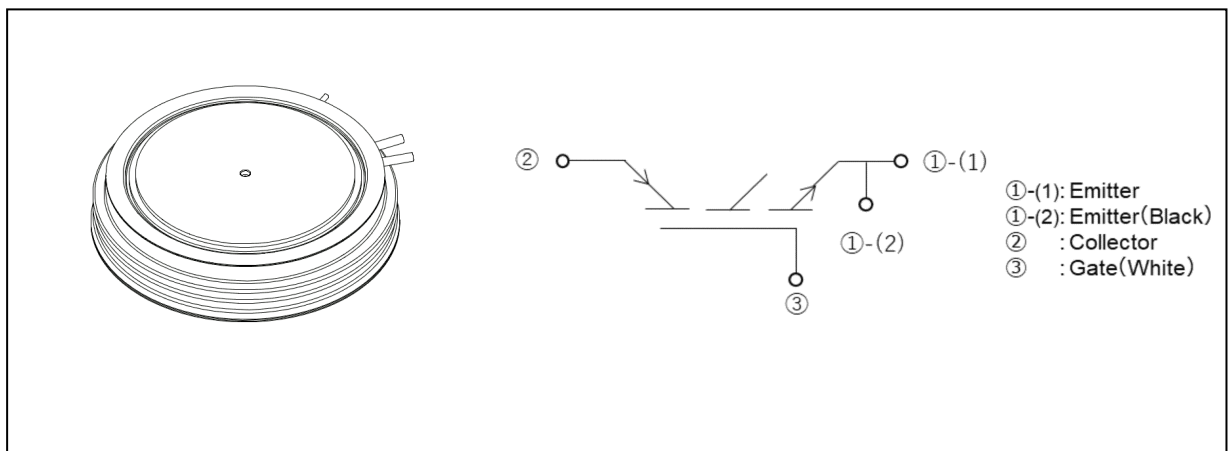

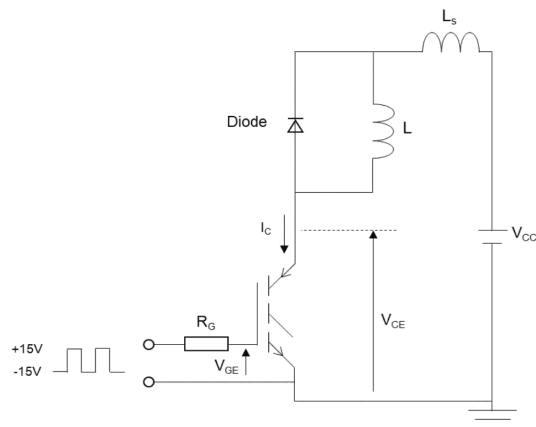


Fig. 6.1 Test Circuit

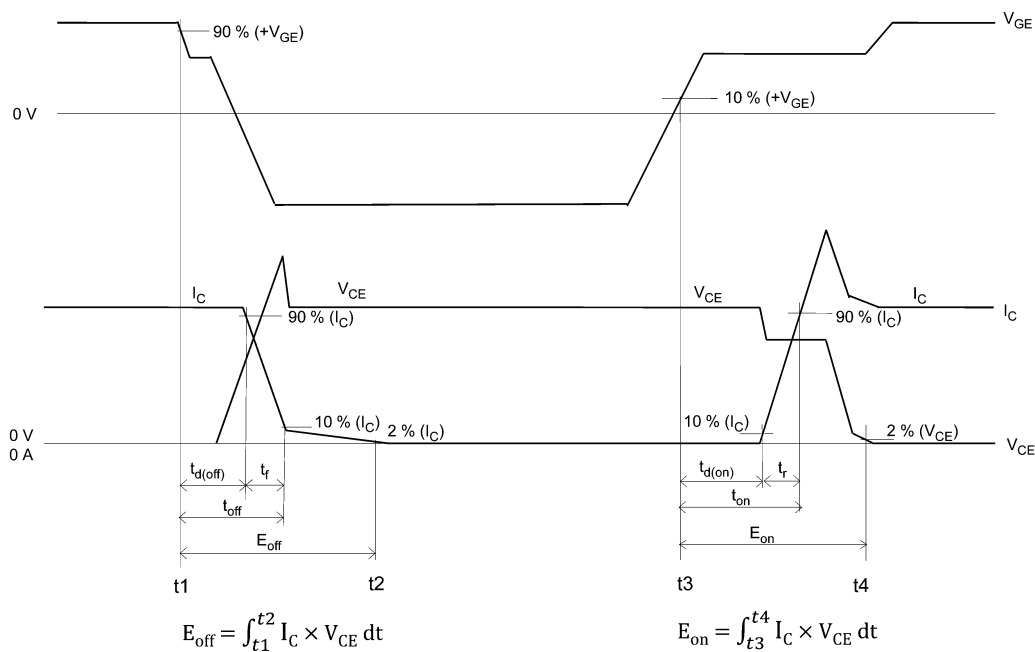


Fig. 6.2 Timing Chart

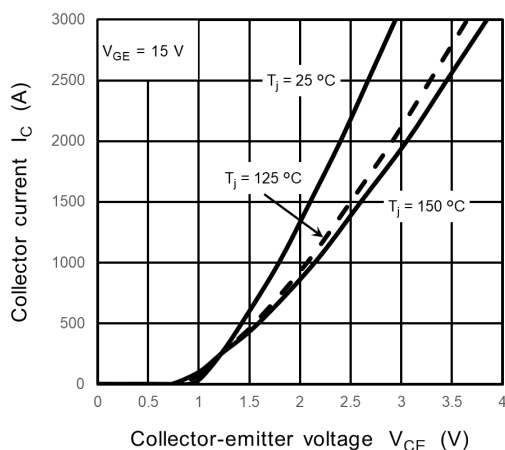


Fig. 7.1 $I_C - V_{CE}$

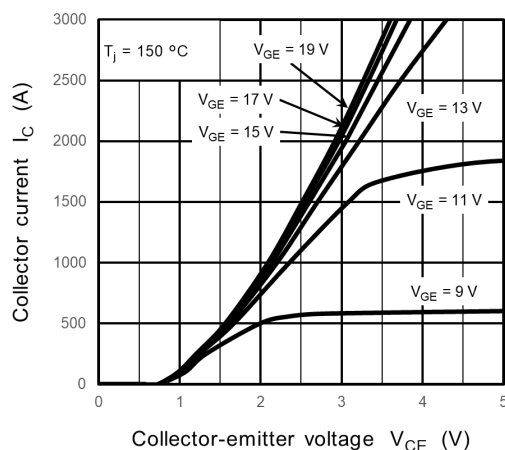


Fig. 7.2 $I_C - V_{CE}$

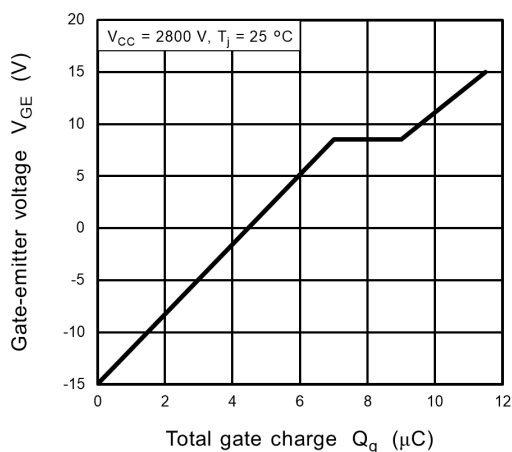


Fig. 7.3 $V_{GE} - Q_g$

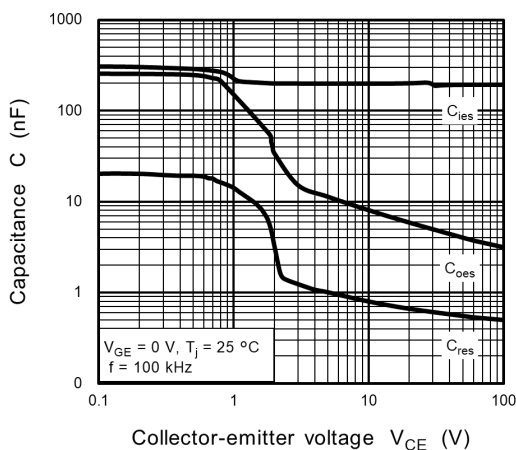


Fig. 7.4 Capacitance - V_{CE}

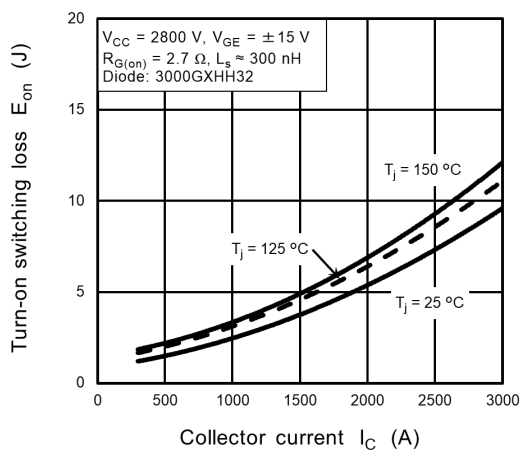


Fig. 7.5 $E_{on} - I_C$

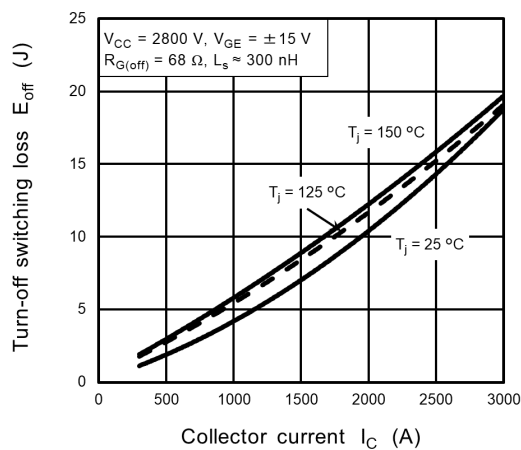


Fig. 7.6 $E_{off} - I_C$

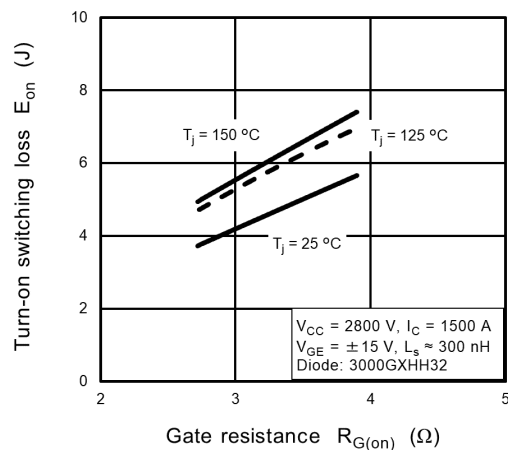


Fig. 7.7 E_{on} - $R_{G(on)}$

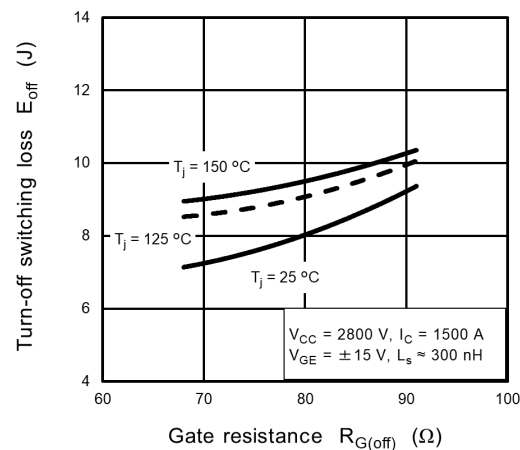


Fig. 7.8 E_{off} - $R_{G(off)}$

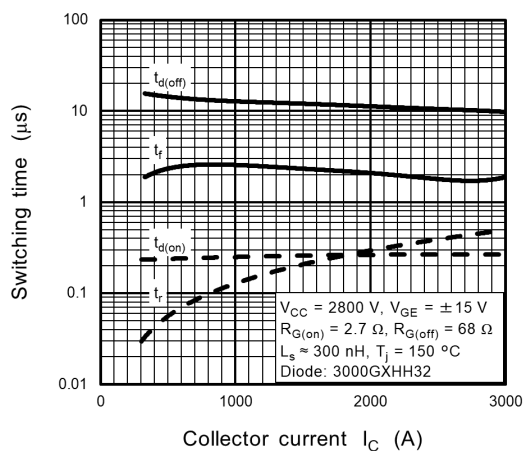


Fig. 7.9 Switching time - I_C

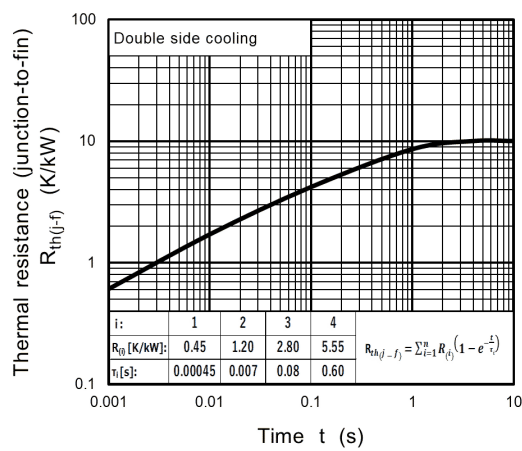


Fig. 7.10 $R_{th(j-f)}$ - t (Guaranteed value)

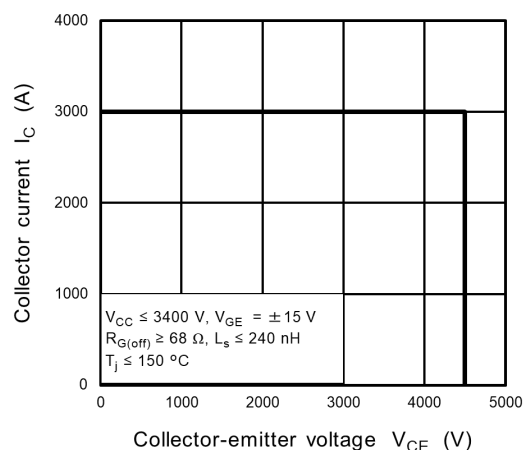
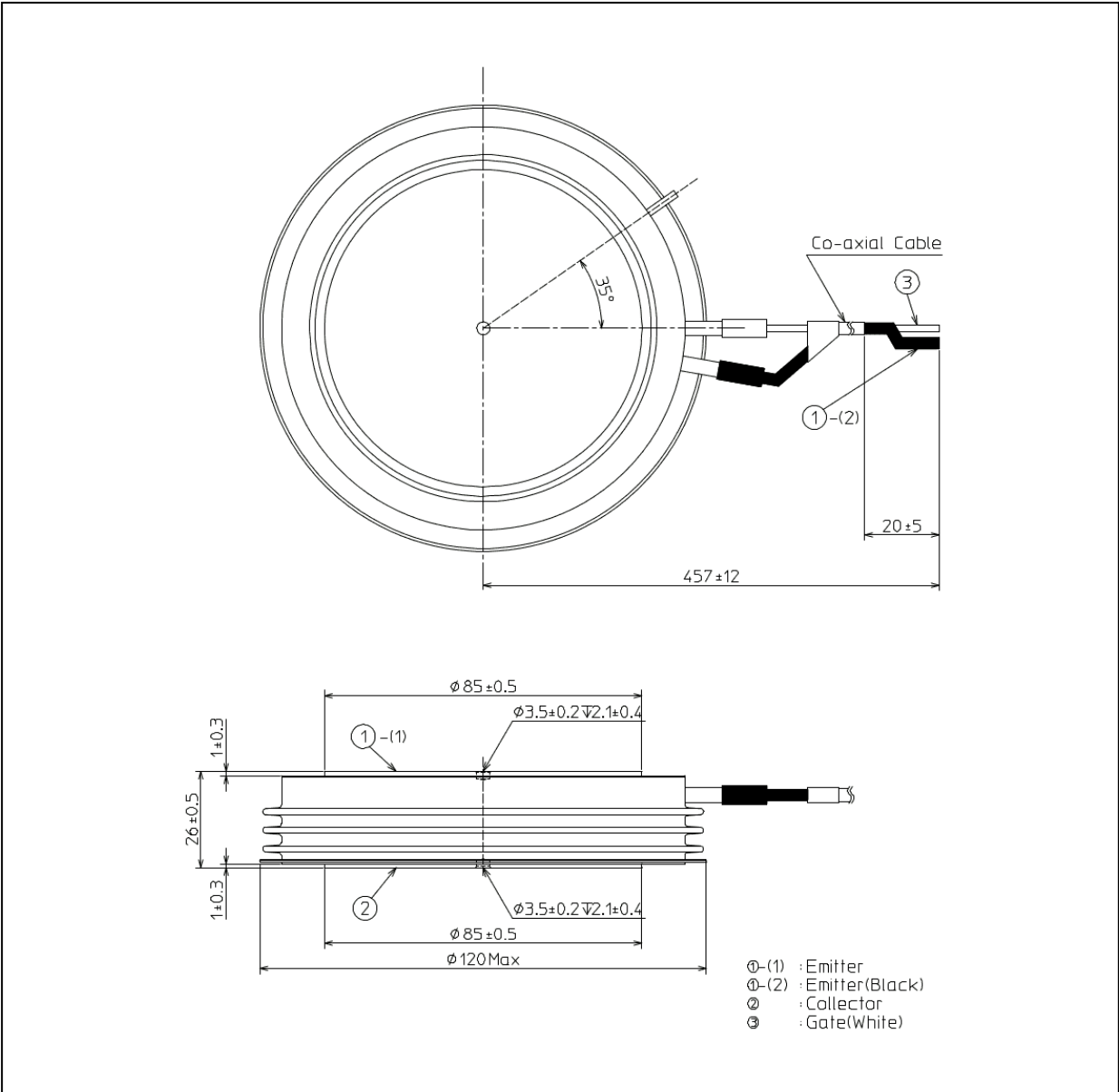


Fig. 7.11 RBSOA (Guaranteed value)
